I was surprised to hear Governor Reynolds announce this week that spiritual and religious gatherings are now allowed, despite the fact that the cases of COVID-19 in Iowa keep mounting.

Based on her statement, some religious communities may decide to gather in the coming weeks, but here at Peoples Church we will be more cautious. And we are not alone.

Faith communities all across the state are resisting Gov Reynold's advice and encouraging one another to refrain from gathering in person at this time.

Perhaps the reason for this is that across all faith traditions, including ours, people are called to love. And during this ongoing global pandemic, love is continuing physical distancing measures as long as is necessary.

Love is keeping one another safe.

Love is staying home.

Love is wearing a face mask in public.

Love is learning new technology and new ways of being together online. Love is being patient and waiting until the time is right to gather in person.

Love is protecting one another from unnecessary risk or harm.

Therefore, Peoples Church will continue to be closed until science and public health officials indicate it is safe to reopen.

For at least the month of May, we will keep our building closed and our hearts and spirits open. We will continue to host all meetings and gatherings, including Sunday morning worship and our May 17<sup>th</sup> Congregational Meeting, online.

The Board, staff, and I are working on a reopening plan which will likely occur in phases. As much as I would love to set an official reopen date and have a big party with you all, I just don't think that will be possible. To keep everyone safe we will have to start small and slowly make changes and adjustments, adding things back into our life together, and gradually working our way back up to full capacity.

# **Zoom Event**Tuesday May 19 7pm CT

IFA, in partnership with a world-class legal team, is leveraging one of the best tools at our disposal to take on the leadership of this violent movement: our justice system.

IFA's groundbreaking lawsuit seeks to hold accountable the neo-Nazis. white supremacists, and other far-right extremists who conspired to orchestrate a weekend of violence in Charlottesville in August 2017, which resulted in Heather Hoyer's death and extensive injuries. This suit — scheduled to go to trial this October 2020 — has the potential to bankrupt and dismantle the leaders and hate groups as the center of this movement.

Join IFA Executive Director Amy Spitalnick for an overview of this landmark case — which is moving full-speed ahead — and the fight against white supremacy, anti-Semitism, racism, and other forms of hate.



Integrity First for America is taking on the leadership of the violent white nationalist movement in court — sending a clear message that violent hate has no place in our country.

We live in fraught times. Anti-Semitism, racism, and other forms of hate are on the rise. From Charlottesville to Pittsburgh to Poway to El Paso, the crisis of violent white nationalism has gone unchecked.



The ADL found a 99% increase in anti–Semitic incidents from 2015 to 2018; anti–Semitic assaults more than doubled in 2018.



Right-wing extremists killed more people in 2018 than any year since 1995—the year of the Oklahoma City bombing.

#### **ABOUT SINES V. KESSLER**

In August 2017, neo-Nazis, white supremacists, and other far-right extremists descended on Charlottesville, Virginia, for what they called "Unite the Right." This rally was not a peaceful protest but, rather, a meticulously planned conspiracy to bring violence to Charlottesville—the result of months of online organizing, fueled by bigotry and hatred. They chanted "Jews will not replace us" and "Blood and Soil." They carried swastikas and other Nazi symbols. And they murdered Heather Heyer and injured countless others.

As the attack unfolded, litigators Roberta Kaplan and Karen Dunn - in partnership with IFA - sprang into action, using the best tool at our disposal to fight back: our justice system.

This landmark federal suit against the two dozen neo-Nazis, white supremacists, and hate groups responsible for the Charlottesville attack seeks to hold them accountable for their conspiracy to commit racially-motivated violence.

#### HOW WILL THIS CASE MAKE A DIFFERENCE?

The court has rejected the defendants' efforts to block this suit and trial is scheduled for October 2020.

This suit is the only current effort to use our justice system to take on the vast leadership of the violent white nationalist movement. It has the potential to uncover who's funding this infrastructure—and bankrupt it. And it sends a clear message: violent hate has no place here.

Once in a generation, there is a trial that fundamentally changes our nation. This will be that trial — laying down a clear marker against organized hate and violence here in America.

This organization is a multifaceted organization based in Montgomery, AL, working to educate people on the history of slavery and the injustices of lynching.

Looking forward, EJI is committed to ending mass incarceration and excessive punishment in the U.S., challenging racial and economic injustice, and protecting basic human rights for the most vulnerable people in American society. People may be familiar with the founder, Bryan Stevenson, for whom the book and movie "Just Mercy" is a biographical tale. EJI also supports the "Lynching Museum" as well as 3 other museums in Montgomery. Members of our congregation have visited these sites and felt profoundly affected by them.

#### **SOCIAL JUSTICE**

Looking to help older adults in need of assistance? United Way of East Central lowa has partnered with Hy-Vee and Lindale Mall to conduct a food drive May 1-3. Food, personal care items, and cleaning supplies can be dropped off at Lindale Mall. Can't make it to Lindale Mall? Order online through aisles online and Hy-Vee will deliver to the site.

The City of Cedar Rapids is seeking donated masks to be distributed to local service agencies and community members in need. Drop-boxes for masks are at City Hall (corner of 1st Ave SE and 1st St SE) & City Services Center front lobby (500 15th Ave SW).

Linn County Department of Public Health's mapping of the COVID-19 virus shows that it is concentrated in low-income neighborhoods where black, brown, and immigrant individuals and families live. Of course, there are systemic social and political reasons for this but not everyone understands this. It is important for us to be vigilant as backlash is to be expected

About 17% of lowans with confirmed cases of COVID-19 are Hispanic or Latino. Yet, they make up only 6% of the state's population. About 9% of the cases are African-American, though only making

up 3% of the population. Latinos and African-Americans are doing the heavy lifting all over the country when it comes to this disease. Race is not to blame but racism that results in disparities in social and economic policies is. Ibram X. Kendi writes in The Atlantic-Stop Blaming Black People for Dying of the Coronavirus. Book Recommendations: Becoming by Michelle Obama and Just Mercy by Bryan Stevenson. Bryan Stevenson is the founder of the Equal Justice Initiative which is our second quarter recipient of our First Sunday Plate Collection. An excellent movie, Just Mercy, was recently released on DVD and Blu-Ray. The EJI has videos explaining their work on their website at www.equaljusticeinitiative.

A consortium of community agencies (Linn Area Partners Active In Disaster) is meeting electronically to determine the needs in the community.

Agencies that work with older adults are identifying food needs and assisting with delivery as grocery stores are swamped with these requests. One hun-

dred inmates were released by the Linn County Jail but the shelters are at full occupancy. Homelessness will undoubtably increase. Catherine McAuley Center is putting out information on the virus in languages spoken by our community members.

Iowa Legal Aid and the Iowa State Bar Association have a phone number people can call if they have legal issues during the pandemic. Either Legal Aide staff or a volunteer attorney will try to respond to questions. The phone number is 1-800-332-0419. The website is www.iowalegalaid.org/ resource/2020-coronavirusoutbreak-what-you-need-toknow. Evictions and mortgage foreclosures for people who have lost employment due to the virus have been suspended by state order. This resource is there to help people understand their legal rights during this epidemic.

St. Marks: The Africans in our neighborhood contacted us about making face masks. Several of our ladies have sewing machines and have started on this project. If anyone from Peoples has any surplus cotton fabric, elastic or bias tape or flat shoestring we can use these for masks. There is a box outside of Christine's office for donations.

You will be placed in a "waiting room" and we will manually welcome you in!


