

# MINISTER'S REPORT

# Rev. Carin Bringelson

Perhaps you wouldn't be surprised to hear that I was a tad overwhelmed when I started at Peoples Church on August 1, 2024. What was going on those 10-ish months ago?

- The Congregational Administrator had been out on medical leave since May 2023. The long-term substitute was fantastic, but neither of us had institutional knowledge. (Christine returned in early September; I continue to learn from and with her.)
- The siding on the west side of the building blew off in a storm in late July. That's when I was surprised to learn there was no active Building and Grounds Committee.
- The Faith Formation program was without a permanent staff person. Since life-long learning and faith development are particular passions of mine, this received lots of my attention.

Since those early August days, we have accomplished much together, including:

- Began the ongoing and important process of getting to know each other.
- Worked with an amazing Board, particularly President Steve Hershner, to...
  - Engage in an October Blast-off Weekend (also known as a "Start-up") with members of the Congregational Life Staff from the MidAmerica (Rev. Phil Lund and Lauren Wyeth)
  - Clarify my priorities of preaching, pastoral care, personnel/administration, and promoting congregational life
  - Affirm the covenant between the Board and me
  - Craft, update, and approve various procedures and policies, including those about flowers, Inclement Weather, Covid, and Funerals
  - Provide ongoing self-training on Board responsibilities
- Crafted and offered a variety of worship services (one of which was zoom-only), with a particular focus on the proposed UU Values crafted by the Article II Study Commission
- Facilitated a Zoom book discussion on the UUA Common Read, On Repentance and Repair: Making Amends in an Unapologetic World
- Established relationships with interfaith partners in Cedar Rapids through...
  - Interreligious Council of Linn County (with a Peace Service in March)
  - Interfaith Alliance of Iowa
  - Voice of Christ connections (including a joint "Spring Clean")
  - Open and Affirming congregations in support of LGBTQ+ communities
  - Colleagues who are the religious leaders of the Youth Co-op congregations

- Hired and supervised a new Director of Faith Formation, Julie Olsen, who served from October – March
- Hired an additional Internet Outreach Technician, Matt Wilde, who began in December
- Supported a volunteer-led Peoples Church Choir
- Provided pastoral visits, cards, and phone calls, in collaboration with PCUU volunteers
- Welcomed 6 new members to PCUU
- Convened a Shared Ministry Team
- Strengthened relationships with UU connections and resources
- Worked with Finance Team and Stewardship Team to ensure appropriate use of the generosity of members/friends
- Co-facilitated a retreat training for Greeters
- Engaged in listening sessions with the Board to brainstorm the next Priorities for Peoples Church
- Planned and experienced a transformational Installation Weekend, with the formal rite of passage on April 27, 2024. # DIRECTOR OF FAITH FORMATION

## **Job Description of the Group:**

Nursery is available for children ages birth through preschool on Sunday mornings.

Faith Formation classes for children ages preschool through 5th grade meet each Sunday from 9:45 a.m. -10:45 a.m. from the Sunday after Labor Day to mid-May with some breaks for holidays.

This year, youth from 6th through 10th grades formed a Coming of Age class, meeting each Sunday from 9:45 a.m. - 10:45 a.m. using the Soul Matters Coming of Age curriculum.

#### **Activities of Note:**

The Faith Formation year started with challenges when both the interim (Ryan Roth-Klink) and settled (David Wise) Directors of Faith Formation resigned, effective June 30 and August 1, respectively. An ad hoc group of staff, board, and parents met over the summer and at the start of the Faith Formation year to discuss plans for the classrooms and strategies to hire a new Director of Faith Formation. Job sharing with another UU church was explored, but ultimately was not feasible. As a stop gap measure, the former interim DFF (Ryan) assisted with volunteer recruitment and the writing of curriculum and the parents and volunteers worked as teachers in the classrooms. Meanwhile, Rev. Carin and Lu Wilcox worked on hiring; Julie Olson was hired as the Director of Faith Formation and started in late October.

The Soul Matters curriculum for the elementary aged children was utilized the most this year with some revisions and additions from the Director of Faith Formation and volunteers. Seasonal parties were enjoyed throughout the year along with a Winter Pageant and Easter Egg Hunt. We had a strong turnout of elementary aged children most Sundays and have grown over the past few months to include new families.

Two consistent volunteers (Deb Booth and Scott Davis) taught the Coming of Age class and they were in the classroom nearly every Sunday. The youth have also been consistent in their attendance, rarely missing classes, and they have welcomed new youth to the group who visit.

The Coming of Age pilgrimage to Louisville, KY was a large undertaking this year primarily orchestrated by Julie Olson with some assistance from Rev. Carin Bringelson and Megan Jones. One teacher (Deb Booth) and two parents (Erin Ogle and Megan Jones) chaperoned the trip with five youth. They visited two churches, met with youth from these churches, participated in lobbying through postcard writing, volunteered at a community food bank and resource center, learned about their sister church's involvement in the Black Lives Matter protest after the Breonna Taylor murder, and visited an African American History Museum called Roots 101. They also enjoyed bonding over fun events such as dinners out and an indoor theme park. The trip was quite inspirational and moving for all who attended. It is the hope of the group that a continued relationship is possible with their Louisville counterparts.

# DIRECTOR FAITH FORMATION CONT.

As part of this trip, the Coming of Age youth have worked to complete 10 hours of volunteer service to benefit the church and its members since last summer. The youth really enjoyed this work and wish to be included in more volunteer opportunities in the future. The Coming of Age service, a culmination of what they have learned and how they have grown into their own beliefs, is planned for May 12, 2024.

The youth have also continued to enjoy their involvement with the Youth Coop, a youth group coordinated by six churches in Cedar Rapids: Peoples Church UU, St. Paul's United Methodist Church (UMC), Lovely Lane UMC, St. Mark's UMC, and St. Stephen's Lutheran (ELCA), and Trinity St. James UMC. The Youth Coop meets Sunday afternoons, rotating churches and other locations for their meetings. They have engaged in learning opportunities, service projects, and fun activities. Members of the Youth Coop will also have the opportunity to attend summer sessions and learning trips. The middle school trip will focus on LGBTQ+ advocacy and the high school trip will focus on work being done to serve the unhoused.

Unfortunately, the Faith Formation year ended with challenges. Julie Olsen resigned suddenly in late March to better care for her health. Thankfully, Megan Jones worked closely with Rev. Carin to ensure classes continued and the Faith Formation year finished strong. Rev. Carin and Lu Wilcox (a parent and a Board member) again will work on hiring a new DFF together. Ryan Roth -Klinck will be PCUU's adult liaison in the Youth Coop so the youth can continue to attend during the search.

# **Continuing Needs:**

Hire a new Director of Faith Formation.

Re-convene a Faith Formation Council to better support and assist the program. (The Faith Formation Council has not been officially meeting since the pandemic.)

Megan Jones plans to hold informal listening sessions with the children, youth, and parents to find out their hopes and dreams for their children's faith formation experience – to better inform planning and hiring for the upcoming year.

More volunteers are always welcome! Often, we rely heavily on parents to volunteer in the classroom which is not conducive to the children and youth forming relationships with other church members. Many hands make light work, and we welcome any who would like to share their gifts with our children and families! (Note: all volunteers will need to consent to a background check.)

## Other Comments:

Another congregational campout hosted by Faith Formation families is in the works for this summer, keep an eye out for updates!

With all the difficulties in transition this year, it should be noted how the families and volunteers really stepped up to keep programming going and nurture relationships between children, parents, families, and volunteers. We extend much gratitude to all who have helped in the Faith Formation program in ways both big and small. Faith Formation is vital for our entire church community and we are stronger because of all of you. Thank you!

# OFFICE REPORT

#### **Office Communications**

- Update our website.
- Maintain Realm database and Mailchimp mailing list.
- Generate weekly newsletter either eWeekly or the Voice.
- Ensure the Order of Service is emailed and printed each week.
- Prepare worship slides and distribute to worship leader, PCUU tech, and pianist, along with OoS.
- Enter events into the church calendar. A monthly calendar is in the Voice and the eWeekly has items for the forth-coming week and items of import for the coming weeks.
- Enter information from "green cards" into Realm and MailChimp; create name tag if requested.
- · Assist with email and phone inquiries.

#### **Facilities**

- Ensure annual inspections are conducted lift, ER lights, smoke detectors, fire extinguishers, fire panel.
- A new snow removal company, who can also provide mowing services, was hired.
- Ensure mowing and snow removal occur in a timely manner. (They are notified when we have special occasions outside of our normal operations.)
- Work with custodian to ensure the building is properly maintained and that seasonal actions occur (snow supplies; dehumidifiers).
- Arrange extra cleaning when necessary. e.g., carpet cleaning
- Program thermostats and change settings with the seasons.
- A Knox Box was ordered and installed by the Gordon entrance. This box contains a building map and keys for the Fire Department to quickly access our building in an emergency.

#### Office Administration

- · Assist the Minister as needed.
- Annual recertification with the UUA (3 of us have a role in this.)
- Bi-annual recertification with the Iowa Secretary of State.
- Supporting the Board of Trustees with the Annual Meeting mailing and Annual Report compilation/distro.
- Gathering/copying/printing materials to support the Stewardship team in the stewardship campaign.
- Serve as primary contact for building rental.
- Liaison with Voices of Christ in their long-term rental and use of our building.
- Maintain worship music and worship calendar spreadsheets for internal use and mandatory CCS license reporting.
- Process payment for guest musicians and others.
- Update the UUA magazine subscription list annually.
- Order office, facility, and worship supplies as needed.
- Enter expenses and reconcile with credit card statement.
- Contacted a variety of churches to enquire about their funeral policies.
- The process of getting a new copier/printer/scanner was started at the end of 2023. The machine is expected in May 2024.

## **Job Description of the Group:**

Providing technical support and audio-visual support to the church, utilizing the sound system and tv monitors, and broadcasting via Zoom, Facebook, and YouTube

#### **Activities of Note:**

Every service is broadcast via Zoom, Facebook, and YouTube. The service on Zoom averages between 11-20 people for each service. The broadcast and clips on Facebook are utilized more for general outreach rather than how our congregation watches the full service. The YouTube broadcast is a live broadcast, but more often people will use it to watch clips of the service after the fact.

Facebook followers have now reached 663 and Instagram has 155 followers.

# **Continuing Needs:**

The area is very open to the public, which means that kids often crawl under the pews and accidentally disconnect the cords. A blocked off area would reduce stress.

Showing videos both on Zoom and to the congregation simultaneously using vMix is a challenge. Our services are improved greatly through vMix by allowing the vMix technician to be able to see all of the sources (the two cameras, PowerPoint, audio channels, videos, etc.) available all on one dashboard. But the software glitches when an external video is played through vMix, resulting in the sanctuary and the YouTube audience being able to hear the video's audio, but Zoom does not receive the audio.

Streaming on Facebook has been challenging. While it sometimes works, there are some technical hoops that can be confusing for the user.

## Job Description of the Group:

The Finance Committee is responsible for the financial activities of the church, including:

- Weekly accounting and deposit of Sunday collection and other income.
- Monthly review of bookkeeper reports, monitoring income and expenses and the church balance sheet, including endowment activity, providing monthly reports to the Board of Trustees (BoT).
- Oversee investments with the Veridian Credit Union and monitor UU Common Endowment Fund (UUCEF) and the Greater Cedar Rapids Community Foundation (GCRCF).
- Provide advice to BoT and the Minister on financial matters.
- Develop church policies and practices for financial operations.
- Development of annual budget, including support to the Stewardship Council.

#### **Activities of Note:**

In 2023-2024 the church continued in its process of achieving long-term financial stability.

- We finished 2023 with a surplus of \$3,058. This was due to strong pledge payments from our members, endowment income and less than expected expenses. This surplus was allocated to reserve funds.
- We have maintained adequate cash reserves, while funding building repairs and paying for our ministerial search. The ministerial search fund ended up with a balance of over \$11k, as costs were lower than expected. These funds are being used to pay for Rev. Carin's installation.
- Our Endowments are contributing a significant portion of our operating income, totaling about \$45,000.
- Averaged over the course of the year, our solar panels generate enough energy to cover 100% of our electrical usage, resulting in monthly electrical bills of about \$22 for grid connection fees and taxes.
- We have continued to operate the committee based on the congregation's policy-based governance and our committee policy document.

# **Continuing Needs:**

We need additional people to help with the weekly deposit, join the committee, or participate in Stewardship Campaign. Besides providing an important service to Peoples, serving on the Finance Committee provides an opportunity to learn about the functioning of non-profit organizations, which is useful experience, both personally and professionally.

#### **Activities of note:**

- Sorted and filed the multitude of materials donated from church members.
- On a request from Radavan Lovci, an historian of Czech Unitarianism in Europe, we determined that Waclav Francis Severa was indeed a member of Peoples Church and his death had been entered into church minutes in 1938.
- Prepared and hung a sign for the Mary Andre room telling of its namesake's history.
- Ordered cast bronze name to the Plaque of Ministers to honor Rev. Rebecca Hinds' service, and ordered one honoring Reverend Carin Bringelson's installation at Peoples Church.
- Reorganized Archive flash drives in an orderly structure with 2579 files, eliminating 618 duplicates.
- Found archival information that the Newton Alliance donated a Silver Service to the church.

# **Ongoing work:**

- Organizing and labeling Photos
- Making decisions based on what really tells the story of our church
- Refining the present filing system
- Developing a policy for materials we receive, the right to refuse or dispose of in an appropriate manner.
